




The FrameGard Anchoring System has been specifically engineered to keep treated glass within the frame when an incident has occurred. It is a mechanical attachment system that clamps the filmed glass to the window frame. This system improves and extends the principle of edge battening by incorporating a specific movement zone (patent applies) which allows the film to move under applied load without putting excessive force onto the fixings and frame. The benefit of FrameGard is that it allows engineers and installers to precisely determine torque settings for each individual installation, creating a truly custom solution.





Blast impact shatters external glass and drives it against the inner pane.



Madico FrameGard movement zone absorbs energy by allowing window film to stretch. Radiused edge prevents cutting of film. Gripped surface clamps film in place.



In the event of glass breakage, the GullWing Anchoring System, when combined with Madico SafetyShield window film, absorbs and disburses the energy that the filmed glass is subjected to and transfers the reduced load over the entire glazed opening. By absorbing and distributing the load, the system retains the filmed glass in the opening and thus reduces the probability of glass fragments and debris from entering the room.

GullWing utilizes a flexible membrane that is adhered to both the filmed glass as well as the window frame which prevents the filmed glass from leaving the opening at all.

The GullWing Anchoring System is offered in three different profile sizes in order to accommodate various window frame configurations. GullWing comes standard in black and can be ordered in other colors upon request (minimum order required).

Anchoring Systems Wet Glaze



In the event of glass breakage, the Wet Glaze Anchoring System, when combined with Madico SafetyShield window film, is designed to absorb and disburse the energy that the filmed glass is subjected to and transfer the reduced load over the entire glazed opening. By absorbing and distributing the load, the system is designed to retain the filmed glass in the opening and thus reduce the probability of glass fragments and debris from entering the room. The Wet Glaze System is economically viable in retrofit applications.



Certified Performance:

SafetyShield 800 with 4-sided Wet Glaze Anchoring System achieves a GSA level 3A performance condition when tested to open range blast loads of 9.0 PSI (62kPa) and 46.0 PSI-ms (317 kPa-ms) on monolithic, annealed glass. A GSA performance condition 2 is achieved when tested to open range blast loads of 7.74 PSI (53kPa), 42.1 PSI-ms (288kPa-ms) on annealed insulated glass units.

Many high performance applications designed to withstand an applied force are built around a sealant bite of 3 /8 inch for wind load applications and 1 /2 inch for blast mitigation. These specifications have proven to perform well in a wide variety of tests. It is critical to performance that the product is installed exactly as tested by Madico. A triangular sealant joint connecting the film to the supporting framing members is required to achieve the full effect of the Wet Glaze system. Concave joints and/or film that does not reach to the edge of the daylight opening will compromise the effectiveness of this attachment method. We recommend the use of Dow Corning® 995 Silicone Structural Adhesive as our testing is based on the use of this high-performing sealant.
